#### *Definitions for Designations and Memberships*

IAAO – stands for the International Association of Assessing Officers which is the internationally recognized leader and preeminent source for innovation, education, and research in property appraisal, assessment administration, and property tax policy. IAAO serves the property tax assessment profession by developing the standards, techniques, and procedures used to maintain accurate property values; the research programs to remain preeminent; the education programs to teach others; the programs for professional designation of assessment personnel to recognize excellence; and the technical assistance and research programs to be the international source for property appraisal, assessment administration, and property tax policy.

ASLA – The American Society of Landscape Architects allows a membership into the organization only after graduation from a four-year minimum certified university with a degree in Landscape Architecture and by passing a state board exam under the oversight of the Council of Landscape Architectural Registration Boards.

MAE – This designation is the highest level issued by the Mississippi State Tax Commission. It stands for Mississippi Assessment Evaluator and is attained by first attending and passing a two-week school held at Mississippi State University, three specific continuing education courses over a period of three years, and three years of property assessment experience. Once the three years of experience and education have been successfully completed, an MAE designation is only issued after passing a rigorous eight-hour appraisal exam that covers all aspects of property valuation including the income approach to value, mapping and surveying, personal property valuations, under the oversight of the Mississippi State Tax Commission.
